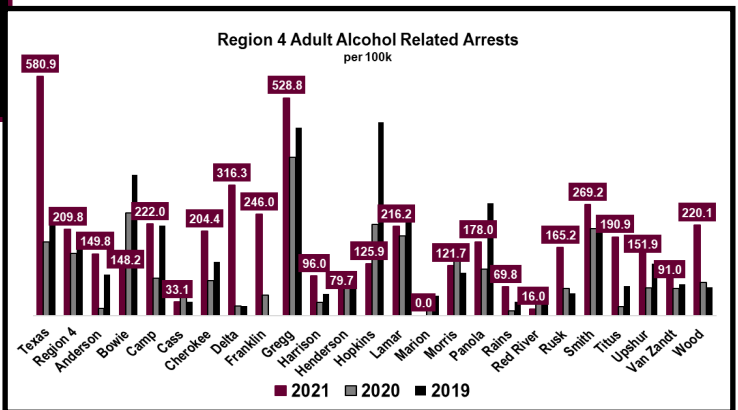

From the Data Desk



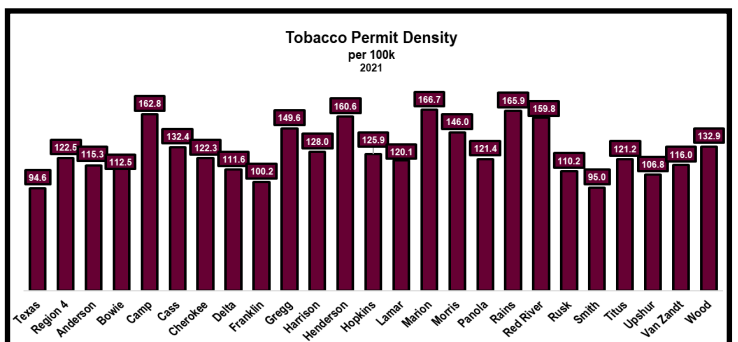
